- Rights:** I irrevocably agree that the Producer may do all things (including omitting to do things) that may, but for this consent, be an infringement of my moral rights (as described in the Copyright Act 1968) or any similar rights. Without limitation, the Producer may use, reproduce and exploit the Materials and the Program in any manner and in any media now known or devised in the future without acknowledging me and/or my appearance.
- Editing:** I agree the Producer has the right (but not the obligation) to use, adapt, edit, delete, juxtapose, add to, delete from, arrange, re-arrange (including re-arranging any sequence of events, questions and answers), revise and/or change the Materials or any part of the Materials and to combine the Materials with other performances and recordings to create further material to be used in connection with the Program.
